Please proof well to ensure all ingredients are listed correctly. Two (2) rounds of changes are included in the initial setup cost. Any and all corrections or adjustments to the recipe should be made during the two rounds of changes allowed. If further changes are requested beyond the two rounds allowed (prior to nutrition facts label being generated), a \$15.00 fee will be added to your order. If any changes are requested after recipe analysis has been approved, and the nutrition facts label has been generated, an additional fee of \$35.00 will be added to the order. It is the client’s responsibility to proof the documentation well and ensure the recipe is accurate. Energyent Inc. will not be held responsible for recipe errors after client approval.

COMPLIANCE PROOFING TERMS

Three (3) rounds of proofing are included in the Label Compliance Review service. Once Energyent provides corrections to be made, it is the client’s responsibility to confirm all corrections have been made by their graphic artist.

If additional rounds of proofing are required beyond the three (3) rounds included, due to corrections not being made, an additional \$50.00 will be incurred per each round of additional edits.
